

# Groovy Food Giveaway Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those 18 and older who reside in the state of Michigan, USA
2. Agreement to Rules: By participating in the Northland Area Federal Credit Union (NAFCU) Giveaway ("You") agree to be fully unconditionally bound by these rules, and you represent and warrant that you meet the eligibility requirements. In addition, you agree to accept the decisions of Northland Area Federal Credit Union final and binding as it relates to the content of this Campaign.
3. Campaign Period: Entries will be accepted online via comments on the Alpena Community College Facebook post on the NAFCU Facebook page beginning at 5:30PM EST on Friday, 3/30/2021 and ending at **the men's half-time** on 3/30/2021. All online entries must be received by 3/30/2021.
4. How to Enter: Entrants must enter a comment on the Northland Facebook post naming what city entrants are watching that night's game from, through the NAFCU shared post, from the ACC Facebook page, including the Lumberjack's link found on Northland Area Federal Credit Union's Facebook page.

The entry must fulfill all Giveaway requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of NAFCU.

You may enter only once. You must provide the required information. You may not enter more times than indicated by using multiple Facebook profiles, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of NAFCU.

5. Prizes: The Winner(s) of the Giveaway will receive a \$40 Hungry Hippie gift card. Value of \$40. The prize shall be solely determined by NAFCU. No cash or other prize substitution shall be permitted except at NAFCU's discretion.

incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Campaign is conditioned upon compliance with any and all federal, state, and local laws and regulations.

In such case, NAFCU may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by NAFCU. NAFCU reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. NAFCU has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering.
