Report from the Nominating Committee

On November 13, 2018 the nominating committee met for the purpose of nominating members to fill positions for three board positions whose terms will soon expire.

Letters of application were received from Howard Spencer, Mike Palumbo and Jimmy Luthmann who are all current board members. With consideration for their experience and willingness to serve the credit union, and that there were no other applications received, the nominating committee recommended to fill the vacancies with the current Board Members.

Nominations for vacancies on the Board of Directors may also be made by petition signed by 1% of the membership. The petitions may be obtained through February 22, 2019 from the President's office. Completed petitions must be received by the President's office no later than 5:00 pm on February 22, 2019. The election will not be conducted by ballot when the number of nominees equals the number of positions to be filled. Nominations will not be accepted from the floor at the Annual Meeting on May 18, 2019.

Howard Spencer

Mr. Spencer has been a credit union member since 1970 and has served faithfully on the Northland Area Federal Credit Union Board of Directors since June of 1974.
