The Federal Reserve has announced changes to Regulation CC that will go into effect on July 1st.

Members who utilize Remote Deposit Capture for their check deposits with Northland Area Federal Credit Union will need to adhere to the following restricted endorsement requirement on the back of each check deposited through Remote Deposit Capture:

- Must be endorsed with signature of payee
- NAFCU or Northland Area Federal Credit Union
- Member account number
- "For Mobile Deposit Only"

### **Enhanced Credit Card Security Coming For Online Purchases**

You may be prompted to enter a one-time passcode to verify the purchase is being made by the cardholder. This one-time passcode will be sent by a method to be selected by the cardholder at the time of the transaction, i.e. email, text.
