- Activities will be held at the Alpena Wildlife Sanctuary Duck Park 1510 W. Chisholm St, Alpena, MI 49707 on Saturday, August 1<sup>st</sup>, 2026
- Evening setup on Friday, July 31<sup>st</sup>, 2026 will begin at 4:00PM and must be completed by 7:00PM. This includes tents, tables, chairs, and large displays. DO NOT display product on evening setup.
- Set up begins at 8:00 AM on Saturday, August 1<sup>st</sup>, 2026, and MUST be completed by 10:00 AM on Saturday, August 1<sup>st</sup>, 2026.
- Parking is only allowed in allocated parking spots, not near vendor space.
- Vendor is to provide their own set up. This includes tables, signage, tents, displays, chairs, and product. Tents are recommended, but not required.
- Electricity will not be provided, however generators are acceptable.
- Take down will begin at 4:00 PM and must be completed by 7:00 PM on Saturday, August 1<sup>st</sup>, 2026. Vendors are responsible for removing all of their belongings and product off of the property.

## Payment:

- Each space is \$20 for a 10x10 square.
- Cash or Checks made out to the cohost: Thunder Bay River Center.
- Submit payment and application to Northland Area Federal Credit Union at 1161 N Bagley St Alpena, MI 49707
- Applications must be turned in to the host Northland Area Federal Credit Union (via email or in-person) by **JULY 27<sup>th</sup>, 2026** to be accepted.
- Payment must be submitted by **JULY 27<sup>TH</sup>, 2026** to guarantee a spot. No space guarantee unless payment is made.
